



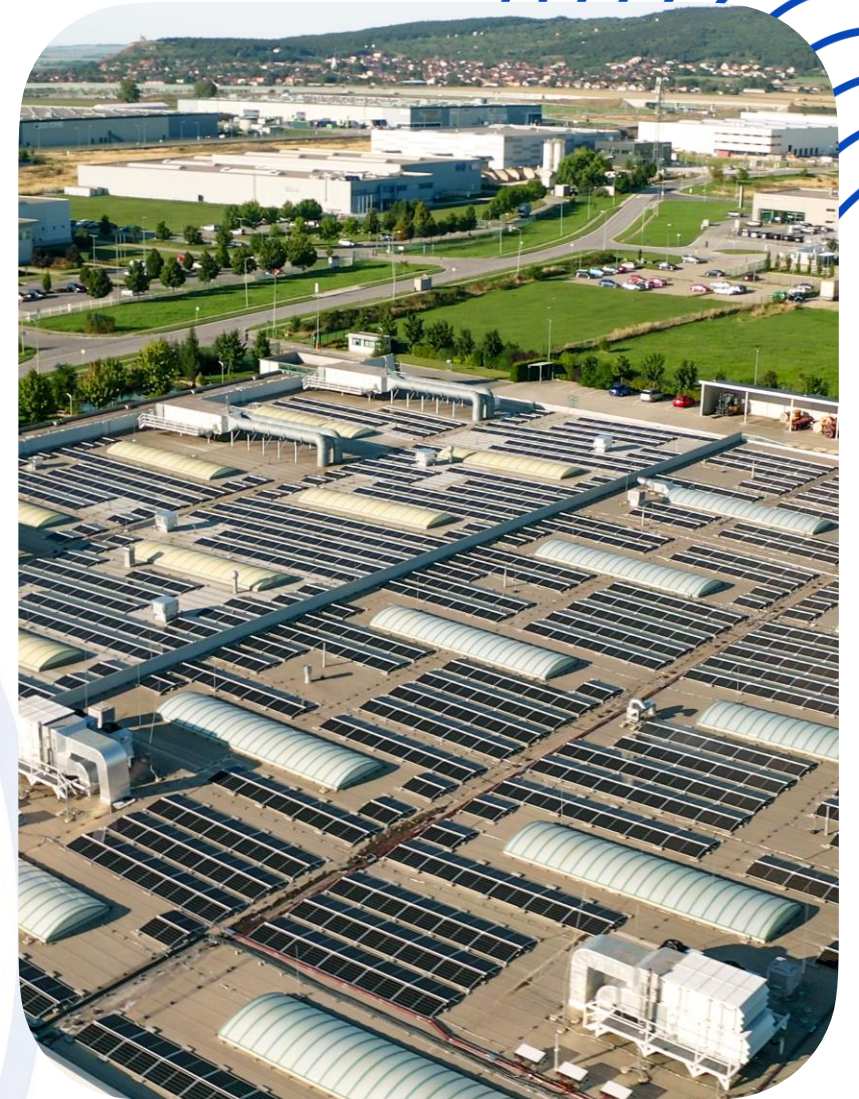
SUMMARY OF ESG ACTIVITIES IN SKB

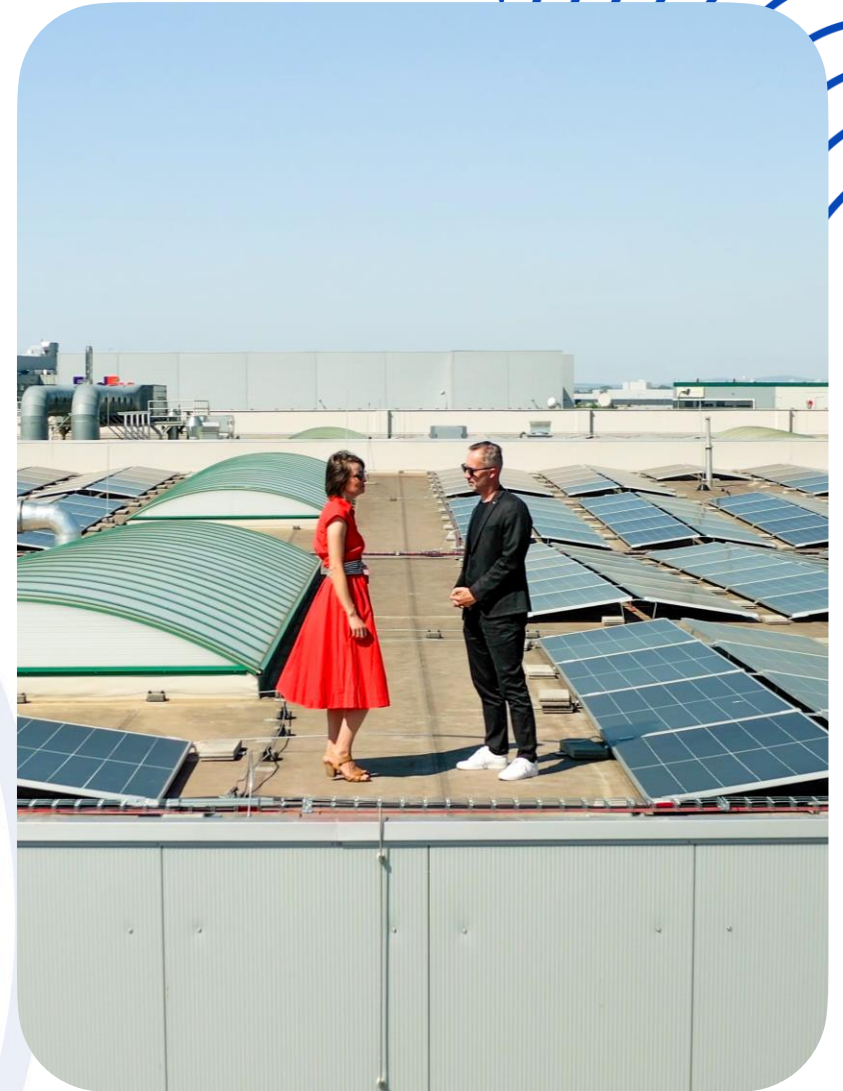

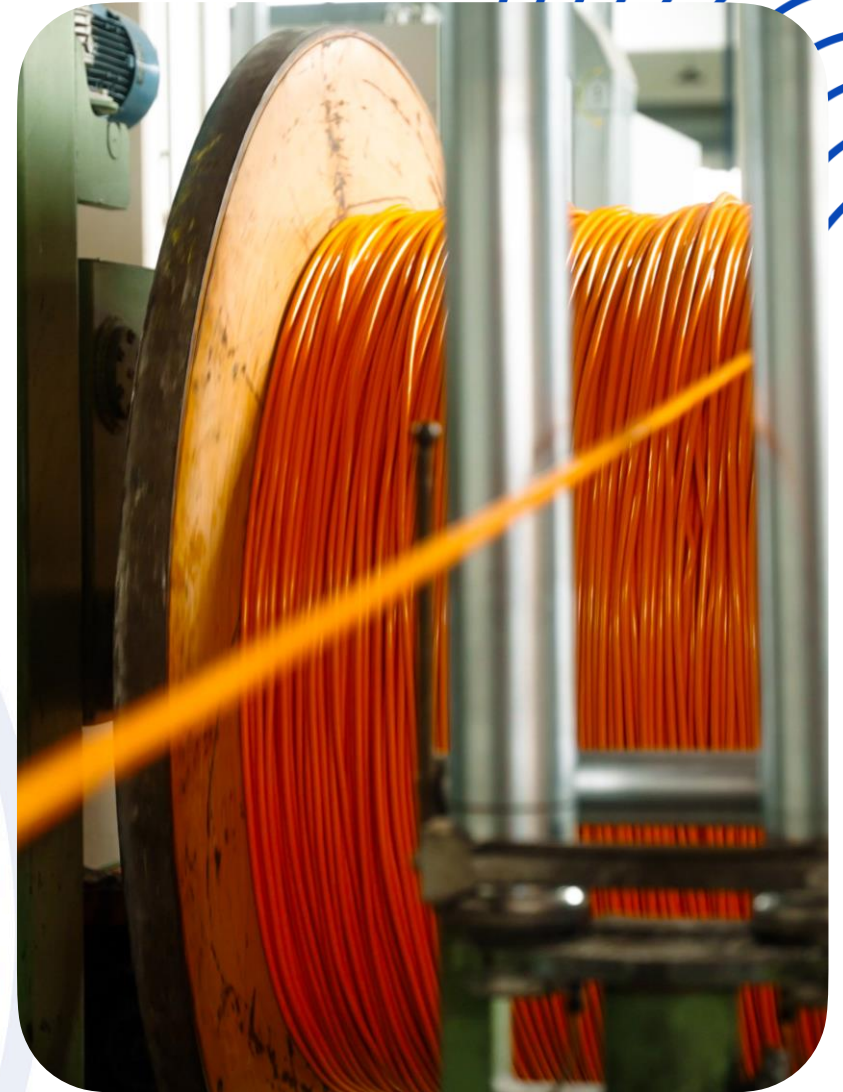


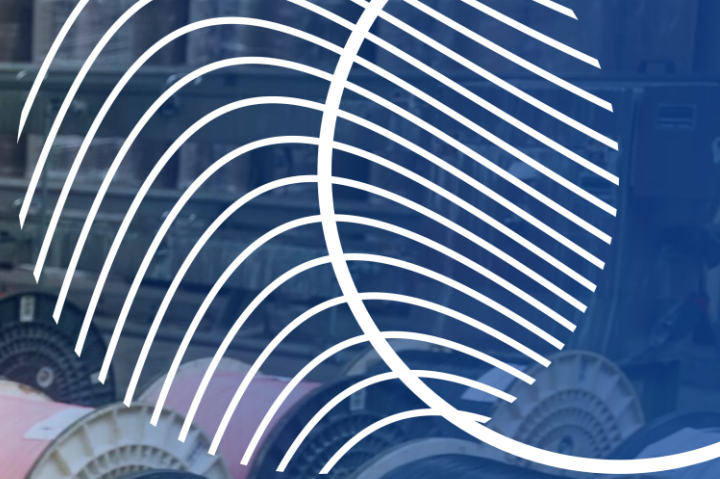
